Members of the First-tier Tribunal for Scotland (Housing and Property Chamber) ("the tribunal"): Martin McAllister, solicitor, legal member and David Hughes Hallett, surveyor, ordinary member.

#### Decision of the tribunal:

The Committee, having considered the representations made by the parties, determined that the property factor enforcement order has been complied with. The Decision was unanimous.

### Reasons:

- The homeowner housing panel made a property factor enforcement order (PFEO) on 15<sup>th</sup> November 2016. The tribunal assumed the functions of the homeowner housing panel on 1<sup>st</sup> December 2016.
- 2. The property factor enforcement order was in the following terms:

Within twenty eight days of service of the property factor enforcement order the property factor is to provide the following undertaking to the homeowner housing panel in relation to its factoring of the development at Dalrymple Court:

- (i) To comply with the Code of Conduct for Property Factors in responding promptly to any future requests or complaints from homeowners;
- (ii) To provide homeowners with details of the proposed insurance cover and renewal details prior to renewal;
- (iii) To comply with Section 3.3 of the Code of Conduct for Property Factors;
- (iv) To ensure that, in future, any documentation sent to commercial tenants in the Development is also sent to the respective owners of the commercial units.
- 3. The property factor wrote to the tribunal on 2<sup>nd</sup> December 2016 and its letter addressed all items in the PFEO. The tribunal was satisfied that the letter contained the undertaking required in terms of the PFEO. The tribunal also noted the terms of an email from the homeowner in which it was stated that the homeowner was satisfied.

The tribunal, having considered the representations made by the parties, determined that the property factor enforcement order has been complied with.

A homeowner or property factor aggrieved by the decision of the tribunal may seek permission to appeal from the First-tier Tribunal on a point of law only within 30 days of the date the decision was sent to them.
