1. The Private Rented Housing Committee ('the Committee') had issued a Repairing Standard Enforcement Order ('RSEO') in respect of the Property dated $13^{\text {th }}$ May 2013. The RSEO relative to the Property required the Landlord to:
'(1) Reinstate the taps and ensure that they are in proper working order.
