# Statement of facts and reasons for Decision to grant Certificate of Completion of Work Under Section 60 of the Housing (Scotland) Act 2006

### Statement of Facts and Reasons

- 1 The Private Rented Housing Committee issued a Repairing Standard Enforcement Order in respect of the Property dated 3<sup>rd</sup> May 2012.
- On 20<sup>th</sup> June 2012 the Tenant's representatives wrote to the Private Rented Housing Committee 2 and confirmed that the works specified in the Repairing Standard Enforcement Order had been completed. The Tenant's representatives confirmed that the Tenant had advised them that the repairs to the property had been carried out and that he was happy with the condition of the property.
- 3 In the circumstances the Committee are satisfied that the requirements of the Repairing Standard Enforcement Order have been complied with and that it is accordingly appropriate to grant a Certificate of Completion.

A landlord or a tenant aggrieved by this decision of the Private Rented Housing Committee may appeal to the Sheriff by summary application within 21 days of being notified of that decision.

Where such an appeal is made, the effect of the decision and the Certificate is suspended until the appeal is abandoned or finally determined. Where the appeal is abandoned or finally determined by confirming the decision, the decision and the Certificate are to be treated as having effect from the date on which the appeal is abandoned or so determined.
