## Statement of Reasons.

The Private Rented Housing Committee re-inspected the property on 22/11/10 in order to ascertain whether the work required by the Repairing Standard Enforcement Order dated 20/9/10 had been completed.

The Landlord's agent attended the re-inspection along with their surveyor Andrew McEwan MRICS. The former tenant is deemed to have withdrawn his application as the tenancy has lawfully ended and this application proceeds on the motion of the Committee.

At the re-inspection the Committee's surveyor member was able to confirm the eastern gable wall had dried out and the property does not currently suffer an ingress of water or dampness. This is in line with the findings of Mr McEwan.

Accordingly the terms of the RSEO have been obtempered and the Committee grants a Certificate of Completion which is attached hereto and forms part of this Statement.

## Right of Appeal
